In the event that Vendor does not exhibit as provided herein or fails to comply in any respect with the terms of this agreement, Northeast Show Promoters, Inc. shall have the right, without notice to the Vendor, to license the use of said space to any other company, enterprise, person or persons, and the Vendor agrees to pay any deficiency, loss or damage by Northeast Show Promoters, Inc. as a consequence of such failure to occupy space as provided in this agreement. In addition, it is agreed that should Northeast Show Promoters, Inc. be unable to license the use of said space as herein provided, it shall have the right to occupy said space for its own purposes without prejudice to its right against the Vendor pursuant to this agreement, including but not limited to the payment of the license fee.

Vendor will not sublicense any part of the space herein provided without the express written consent of Northeast Show Promoters, Inc.. In the event the Vendor premises are destroyed or rendered unavailable for any reason whatsoever (whether before or during the scheduled exhibition), the rights of the Vendor under this agreement shall be limited to a pro-rata refund of the amount paid for the space licensed.

Northeast Show Promoters, Inc. shall have the right to make such rules and regulations in connection with the Vendor as it may deem proper and may amend them at any time and Northeast Show Promoters, Inc. shall have the full power in the matter of interpretation and enforcement thereof. The rules and regulations heretofore referred to are printed on this agreement and are incorporated herein by reference. Vendor agrees to abide by said rules and regulations.

It is agreed that this instrument is a license, and not a lease; and that no leasehold or tenancy is intended to be or shall be created hereby.

This agreement cannot be varied, modified or canceled by the Vendor without the express written consent of Northeast Show Promoters, Inc.

IN WITNESS THEREOF, the Vendor has caused this application and agreement to be duly executed by an authorized representative.
